

# General Rules



- This Flower Show conforms to the standards established by the National Garden Clubs, Inc. (NGC). The Handbook for Flower Shows (HB), 2017 Edition, with revisions posted on the NGC website, is the authority for all issues not covered by the schedule, which is The Law of The Show.
- Entries in Division I, II, III and IV are open to all Shippan Point Garden Club members. Entries in Division V are open to residents of Shippan Point who are not members of SPGC.
- Entry cards will be available from the Entries Chair, Cathy Bertasso (cathyroc@yahoo.com) and the General Chair, Nolini Barretto (barretto.nolini@gmail.com). Entry cards will be available from June 1, 2025.
- 4. Exhibitors must fill out entry cards in advance (typed, in water-proof ink, or in pencil) and bring with their exhibits on the day of the show. Division V exhibitors (non-SPGC members) who need assistance can reach out to Liz Deambrosio (lizdeambrosio@hotmail.com) or Kristin Hayes (irisheyes006@hotmail.com).
- 5. Entries in Design, Botanical Arts, Education Exhibits and Horticulture Section K: Heritage Container Plants will be accepted on Wednesday, July 16, 2025 between 5 pm and 7 pm at the Stamford Yacht Club. All other Horticulture entries will be accepted on Thursday between 8 am and 10 am. Exhibits must be removed Thursday, July 17, 2025, between 6:15 pm to 7:15 pm.
- 6. Judging will begin at noon on July 17, 2025.
- 7. The Classification Chair for each Division checks exhibits for conformity to the schedule prior to judging. Final determination for conformance is the Judges' responsibility.


# General Rules (cont.)

- 8. The General Chair and the Chairs for each division are available during judging for possible consultation with the Judges and Clerks. Only they are allowed on the floor during judging.
- The decisions of the Judges are final. Awards may be withheld if not merited.
- 10. There must be an emphasis on FRESH plant material; no artificial plant material is permitted in any exhibit or in any Division.
- Each exhibitor is limited to one entry per class, except in the Horticulture Division if each is a different species, variety, cultivar, type or color.
- 12. The Shippan Point Garden Club will strive to assure the safety of all items after arrival and placement but is not responsible for any loss or damage to exhibits.
- 13. Plant material listed on the following websites is prohibited in any Division. Please consult:

# National Garden Club Awards

### The NGC Standard System of Awarding is used in all Divisions:

- One (1) first-place (blue) ribbon per class or subclass; 90+ points
- One (1) second-place (red) ribbon per class or subclass; 85+ points
- One (1) third-place (yellow) ribbon per class or subclass; 80+ points
- Honorable mention (white) ribbons as merited; 75+ points

#### **DIVISION I: Horticulture**

**Award of Horticultural Excellence.** One is offered to the highest scoring, correctly named, blue-ribbon exhibit, scoring 95 or above, judged to be the finest in the entire Horticultural Division. *Rosette of green, blue and orange ribbons.* (HB pg. 40)

**Award of Merit.** Eight are offered to the highest scoring, correctly named, blue-ribbon winner, scoring 95 or above, meeting all requirements in Sections A, B, C, D, E, F, H, and I. Rosette of orange ribbons. (HB pg. 41)

**Arboreal Award.** One is offered to the highest scoring, correctly named, blue-ribbon winner, scoring 95 or above, meeting all requirements in Section G. Rosette of green ribbons. (HB pg. 40)

**Collector's Showcase Award.** One is offered to the highest scoring, correctly named, blue-ribbon winner, scoring 95 or above, meeting all requirements in Section J. Rosette of brown and green ribbons. (HB pg. 41)

**Grower's Choice Award.** One is offered to the highest scoring, correctly named, blue-ribbon winner, scoring 95 or above, meeting all requirements in Section K. Rosette of dark green ribbons. (HB pg. 41)

### **DIVISION II: Design Awards**

**Designer's Choice Award.** One is offered to the highest scoring blue-ribbon winner meeting all requirements in Section A, Classes 1, 2, and 3. Rosette of purple ribbons. (HB pg. 42)

# NGC Awards (cont.)

### **DIVISION III: Botanical Arts Awards**

**Botanical Arts Artistic Crafts Award.** One is offered to the highest scoring blue-ribbon winner meeting all requirements in Section A, Classes 1, 2, and 3. Rosette of navy-blue ribbons. (HB pg. 44)

### **DIVISION IV: Education Awards**

**Education Top Exhibitor Award.** One is offered to the highest scoring blue-ribbon winner meeting all requirements in Section A, Class 1. Rosette of brown and white ribbons. (HB pg. 43)

**Award of Appreciation.** One is offered and may be awarded to invitational non-competitive Exhibits, if merited, which are not to be judged. Rosette of orchid ribbons. (HB pg. 45)

### **DIVISION V: Shippan Point Residents Horticulture Awards**

**Award of Appreciation.** Three are offered and may be given to the highest scoring winners in Sections A, B, and C. Rosette of orchid ribbons. (HB pg. 45)

# SPGC and FGCCT Awards

**SPGC Sweepstakes Ribbon: Horticulture Award.** One is awarded to the member with the greatest number of points in the Horticulture Division, Sections A through K. Rosette of green and white ribbons.

**SPGC Sweepstakes Ribbon: Design Award.** One is awarded to the member with the greatest number of points in the Design Division, Section A, Classes 1, 2, and 3. Rosette of green and white ribbons.

**FGCCT Connecticut Silver and Blue Award.** Up to three may be awarded to Education Exhibits scoring 90 points or more at the discretion of the judges. Rosette of silver and blue ribbons.

# DIVISION I: Horticulture

#### HORTICULTURE RULES

- 1. The NGC Exhibit Policies are printed in the Handbook for Flower Shows (HB), Chapter 6, pg. 55. Exhibiting in the Horticulture Division.
- The rules for a single species cut or container-grown specimen are listed in HB, its supplement Horticulture Exhibiting and Judging and the SPGC website.
- 3. To receive an NGC Top Exhibitor Award, the exhibitor must identify the entry by its binomial name or currently acceptable scientific designation. (See HB, Exhibiting in the Horticulture Division, Chapter 6.)
- 4. Entry cards are to be filled out in advance. (Cards can be typed, written in waterproof ink or pencil.) Refer to HB, Chapter 6 for a correctly filled-out entry tag.
- 5. Cut specimens can't have foliage below water line, except for Gladiolus.
- 6. If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may flower but should be exhibited as a foliage plant if they are grown for their leaves.
- 7. Specimens with a class designation in the schedule may not be entered in the 'Any Other Worthy' class.
- 8. See HB Chapter 14 for The Scales of Points for Horticulture.
- 9. Entries are one cut stem, unless otherwise noted, in clear glass bottle provided by the exhibitor.
- 10. Four entries per Class are permitted by an exhibitor unless otherwise noted. When multiple entries are permitted in a class, each entry must be a different cultivar. Classification may subdivide as necessary.
- 11. Wedging by the exhibitor is permitted using clear cling wrap.
- 12. Anchoring to add weight to the container is allowed using unobtrusive glass marbles, pebbles, etc.
- 13. Double potting is allowed. Inner pot must not be visible. Unobtrusive staking is permitted.

# SECTION K: Heritage Container Plants

"Remember Then" The Earls, 1963

Must be owned and grown solely by the exhibitor. Maximum container size: 15 inches. Exhibitor must be able to carry and transport the container.

Must pre-register via Sign-up Genius on SPGC website by June 15, 2025 and brought in for Classification on July 16.

One Exhibit per class/per exhibitor. Eligible for Grower's Choice Award.

- Class 48: Grown for at least 5 years
- Class 49: Grown for 5-10 years
- Class 50: Grown for 10-15 years
- Class 51: Grown for over 15 years

# DIVISION II: Design

"Imagine" John Lennon, 1971

#### **DESIGN RULES**

- The NGC Exhibit Policies are printed in the Handbook for Flower Shows (HB), Chapter 7, Exhibiting in the Design Division, NGC Policies and Guidelines.
- 2. Advance pre-registration with the Design Chair Dianna Dwyer is required by June 1, 2025.
- 3. Design entries must be installed on Wednesday, July 16, 2025 between 5 pm and 7 pm at the Stamford Yacht Club. Exhibits must be removed Thursday, July 17, 2025, between 6:15 pm and 7:15 pm.
- 4. Some plant material must be used in every exhibit. This includes fresh and/or dried plant material.
- 5. See HB, Chapter 7 for plant material and non-plant material permitted and not permitted in the Design Division.
- All plant material used in the design must be identified on the entry card, provided by SPGC. Contact Design Chair Dianna Dwyer or Cathy Bertasso for entry cards.
- 7. The exhibitor is required to conform to the stated description and limitations of the Design Type named in the class.
- 8. Rules for Design Types, Advanced Design Types, Table Designs and Table Appointments are printed in HB, Chapter 7.
- 9. The Scales of Points for Design is listed in HB, Chapter 14.
- 10. Designer is on her/his honor that the design being entered has not been previously entered or judged in an NGC Standard Flower Show.
- 11. Exhibitors may enter multiple classes within the Design Division, but only one (1) exhibit per class.
- 12. The exhibit entered in the competition must be the work of only one (1) exhibitor and that exhibitor must appear on the entry card.
- 13. All designs are Creative. See HB Pg 75.

# SECTION A: "Build Me Up Buttercup" The Foundation, 1968

All Classes eligible for the Designer's Choice Award, if merited. Four pre-registered entries exhibited per Class.

### **CLASS I: Roaring Twenties**

"Moonglow" Will Hudson & Irving Mills, 1933

### **Reflective Design**

A Creative design staged on a 40" high, 24" diameter round pedestal draped to the ground with a white skirt. Exhibit may not exceed the diameter of the pedestal but may be of unlimited height. Exhibit will be judged from the front against a pale-yellow wall.

### **CLASS II: 1940s Skyscrapers**

"Skyscraper" Demi Lovato, 2011

### **Parallel Design**

A Creative design staged on half of a 6' long x 30" wide x 30" high table draped with a white tablecloth and skirted to the ground. Exhibit may not exceed 24" wide and deep, and 36" high. Exhibitor must provide background and underlay to complement the design. Exhibit will be judged from the front.

# CLASS III: 1960s Counterculture Movement and Beatle Mania

"Twist and Shout" Beatles, 1963

### Multi-Rhythmic Design

A Creative design staged on a transparent Lucite pedestal 12" square x 40" high. Exhibit may extend up to 6 inches beyond the dimensions of the pedestal in any direction. No restrictions on height. Exhibit will be judged from the front against a pale-yellow wall.

# DIVISION III: Botanical Arts— Artistic Crafts

"Celebration" Kool & The Gang, 1980

#### **ARTISTIC CRAFTS RULES**

- All Artistic Crafts exhibits must contain a majority of fresh and/or dried plant material and/or fungi. Only dried plant material may be treated. Plant material must be in its natural form/state. No artificial, endangered, or locally invasive plant material may be used. Please refer to the policy on use of native and invasive plants websites noted in the General Rules on page 4 of this brochure.
- 2. The Scale of Points for judging Botanical Arts Artistic Crafts listed in Chapter 14 of the NGC Handbook for Flower Shows (HB).
- 3. Advance pre-registration with Artistic Crafts Chair Rusty Ruth is required by June 1, 2025.
- 4. Artistic Crafts entries must be installed on Wednesday, July 16, 2025, between 5 pm and 7 pm at the Stamford Yacht Club. Exhibits must be removed Thursday, July 17 between 6:15 pm and 7:15 pm.
- 5. The rules for Botanical Artistic Crafts are printed in HB, Chapter 10.
- The Exhibit must be the work of the Exhibitor under whose name it is exhibited.
- 7. No artificial plant material is permitted in any exhibit. Non-plant material may be used for construction but must not be seen.
- 8. Plant material may not be carved into figural forms; however, such forms may be assembled from plant material. Clipping, cutting, or shaping of material is allowed.

# Artistic Crafts Classes

SECTION A: "Out of My Dreams" Rodgers & Hammerstein, 1993

Four pre-registered entries exhibited per Class. A 5" x 8" Key Card of materials used is required in all Classes (if more space is needed, use two 5" x 8" cards). Highest scoring entry eligible for the Botanical Arts Artistic Crafts Award.

### Class 1: 100th Anniversary Celebration Invite

"Happy Birthday!" Stevie Wonder, 1980

Create an invitation inviting all to attend SPGC's Centennial *Celebration*. Decorate using pressed, dried, or fresh plant material. Size of invitation should not exceed 12" x 12" x 12". Invitations will be judged from the front but may be visible from all sides. Invitation may be displayed on a card stand supplied by exhibitor. It will stand on a white tablecloth.

### Class 2: 100th Anniversary Cake

"If I Knew You Were Coming, I'd 've Baked a Cake!" Eileen Barton, 1950

Create a faux celebration cake made of any natural botanical material (no artificial material) decorated with fresh or dried plant material. Cake should not exceed 18" x 18" x 18". Cake may sit on a cake stand, plate or tray provided by the Exhibitor. Exhibit will be displayed on a white tablecloth. Judged from the front but viewed from all sides.

### Class 3: Signature Mocktail

"Ladies Who Lunch" Stephen Sondheim, 1970

Create a unique fake cocktail made of only plant material presented in a cocktail glass or stemware. Give it a signature name. Size should not exceed 10" x 10" x 10". The cocktails are judged from the front but may be viewed from all sides and are placed on a white tablecloth.




# **DIVISION IV: Education**

"ABC" The Jackson 5, 1970

#### **EDUCATION DIVISION RULES**

- Education exhibits may be the work of more than one individual or organization unless a Student Judge, or Accredited Judge is seeking exhibiting credit.
- 2. Exhibits in Section A are competitive.
- 3. An exhibit must occupy a minimum of 18-square-feet surface area.
- Scale of points for Education Exhibits is listed in The <u>Handbook</u> <u>for Flower Shows</u>. Chapter 14.
- The use of plant material is not mandatory but encouraged. Artificial plant material is not permitted.

- 6. Exhibits 1 through 4 will each be on their own tables which are 6'(W) x 29"(D) x 29"(H), covered and skirted to the floor in a white tablecloth.
- 7. Advance registration with the Education Entries Chair, Janet McCabe is required by May 1, 2025.


